The Team consists of product specialists, consultants, Frontend- and Backend-Developers as well as organizational developers. Among their customers are a variety of large and well-known companies, such as Raiffeisen Bausparkasse.

2. Mortgage loan – From Digitalization to Innovation

Monika Hoffmann und Verena Heil (viable GmbH)

Ms. Hoffmann and Ms. Heil are highlighting how important it is for financial institutions to drive digital innovation and to provide resources to do so. To make sure one is well-equipped for market-challenges ahead, following aspects are essential:

- Analyzing the user behavior and derive actions from it
- Simplification of complex processes through cooperation (in “cross-functional” teams), direct communication and transparency
- Creation of a flexible and reusable IT-infrastructure (step-by-step)

Based on two case studies the speakers illustrate possibilities for implementing the above-mentioned aspects in the online area of financial institutions with a focus on mortgage loan business. Raiffeisen Bausparkasse, for instance, developed an end-to-end online mortgage loan, which is fully automated up to the point of financing decision.
